Dear Secretary Bernhardt,

The LWCF Coalition is extremely thankful that earlier this summer Congress passed and the President signed into law the Great American Outdoors Act (P.L. 116-152), which among its provisions provided full, permanent funding for the Land Water Conservation Fund (LWCF), America's premier conservation and outdoor recreation program. We thank you for your support and are eager to work with you and others in the Department to ensure the success of this landmark legislation and hope you will engage us in implementation of GAOA now and into the future. The LWCF Coalition is made up of thousands of groups, businesses and individuals who advocated over the past decade for both permanent authorization and full, dedicated funding for LWCF, and will continue to advocate for its full potential through on-the-ground successes.

LWCF is the most important source of federal funding for the protection of land within national, state, and local parks; national wildlife refuges and state wildlife areas; national and state forests; historic sites; national, state and local trails; and other important outdoor recreation sites. LWCF has ensured public access to outdoor recreation in every state and thousands of communities across the nation. Given the current coronavirus pandemic and the restrictions it has placed on so many activities, the public's ability to access the outdoors has never been more important from both a physical and mental health standpoint. With enactment of GAOA, the revenues deposited into the LWCF account can at long last be fully applied, without diversion to other non-conservation spending, to vital federal and non-federal land conservation projects that address these needs.

As you know, the legislation requires that the President submit to Congress "detailed account, program, and land conservation project allocations" for each year's LWCF funding, with the proposed allocation for FY 2021 due no later than ninety days after the August 4th date of enactment. The legislation further provides that congressional appropriations acts may make alternative allocations among the LWCF federal acquisition and state and local conservation and recreation programs. The FY 2021 land acquisition project lists the Department previously submitted for the four federal land management agencies, at 150% of FY 2020 enacted levels, provide a strong foundation for the additional LWCF project allocations now required by the GAOA.

As you augment these FY 2021 lists to allocate all current-year LWCF deposits among federal agency land acquisitions and the distinct conservation and recreation grant programs funded under LWCF, we hope and expect that the Department will meet this legal deadline in order to address urgent LWCF priorities and to allow for meaningful congressional review. In

accordance with the formula established under last year's permanent reauthorization legislation, the Administration's submission should provide for:

- No less than 40 percent of those deposits for federal agency land acquisition project needs across the four land management agencies (BLM, FWS, NPS, and USFS); and
- No less than 40 percent of those deposits (including GOMESA funds) to the five LWCFfunded state and local grant programs, which per the provisions of FY20 Interior Appropriations bill are the following:
  - NPS State and Local Assistance Program, including its urban-focused competitive component, the Outdoor Recreation Legacy Partnership Program
  - Forest Legacy Program
  - Cooperative Endangered Species Conservation Fund
  - American Battlefield Protection Program
  - Highlands Conservation Act; and
- A 3% or \$15M set-aside of funds specifically for recreational and sportsmen's access projects

We also urge the Administration to ensure, after meeting the 40 percent federal land acquisition and 40 percent LWCF state and local grant programs thresholds detailed above, that the remaining 20 percent of the funds be appropriately divided among these LWCF programs in a balanced way that addresses each year's most compelling needs.

The LWCF Coalition stands ready to work with the Administration and Congress to ensure the successful implementation of the Great American Outdoors Act. Given the depth and breadth of LWCF experience and expertise on the part of the Coalition and its members, we respectfully ask that you include us to the fullest possible extent in the Department's public process for GAOA implementation regarding LWCF. In that same spirit, we thank you and your staff for your efforts to continue the success of this vital and widely supported program.
