Dear Senators Murray and Cantwell and Representative Marie Gluesenkamp Perez:

The undersigned 42 conservation, recreation, and wildlife organizations as well as local businesses, elected officials, and other concerned interests are writing to urge you to support the Green River Valley Alliance in their efforts to secure a mineral withdrawal in the Green River Valley located in the shadow of Mount St. Helens to protect this important landscape from the threat of mining.

For over 15 years, Ascot Resources Ltd., a Canadian mining company, has been seeking permits to conduct exploratory drilling for copper, gold, and molybdenum in the Green River Valley bordering the Mount St. Helens National Volcanic Monument. Time and time again, the proposal has been met with local opposition related to concerns about environmental, cultural, and economic impacts to southwest Washington.

The Green River Valley is beloved by many for its scenic views, its remote and peaceful location, and for its boundless outdoor recreation opportunities. People visit from around the region and the world to enjoy world-class hiking, mountain biking, backcountry horseback riding, fishing, hunting, botanizing, foraging, and more - helping to fuel the local economy in the process. The Green River Trail, Goat Mountain Trail, & Green River Horse Camp, all frequently used by outdoor enthusiasts, would likely be destroyed or rendered inaccessible if a mine were to be constructed here.

The Green River is eligible to be a Wild & Scenic River candidate, in part due to the fact that it is a designated gene bank river for wild steelhead, offering critical spawning and rearing habitat for this iconic species. The river also provides fresh drinking water to tens of thousands living in downstream communities around Kelso and Castle Rock as it flows into the North Fork Toutle River and then the Cowlitz River.

The proximity of the Green River Valley and Mount St. Helens creates other concerns for public health as well. The risk of nearby volcanic activity increases the likelihood of potential mining-related accidents, such as a tailings pond breach, which would contaminate the Green River with toxic mining wastewater, devastate plants and wildlife in the area, and pollute this source of fresh drinking water for downstream communities.

Economically, there could also be negative impacts on tourism and outdoor recreation. It is estimated that roughly 61% of all jobs in the communities here along US Highway 12 rely on the outdoor recreation industry and a number of related industries such as hospitality, retail, and food services. While the Green River Valley is fairly remote, the construction of a massive openpit mine just outside of the National Volcanic Monument would likely decrease the number of visitors to that part of the forest. At the same time, the mining industry is increasingly becoming more automated meaning that any local jobs created would likely be few and far between and these short-term gains would likely come at the cost of long term environmental and economic consequences.

This landscape is also culturally and spiritually significant to the Cowlitz Indian Tribe and the Confederated Tribes and Bands of the Yakama Nation. Mount St. Helens (Lawetlat'la) is listed in the National Register of Historic Places as a Traditional Cultural Property of both Tribes due to its significance in traditional beliefs and cultural identity. Both the Cowlitz Indian Tribe and the Yakama Nation strongly oppose proposed mining efforts in this area because of impacts on their tribal treaty rights and lifeways.

We are asking you to support the Green River Valley Alliance in their efforts to secure a legislative mineral withdrawal for the Green River Valley. This designation would end the threat of mining by prohibiting mineral extraction within the boundaries of the roughly 46,000 acre withdrawal area. This designation would not impose any additional restrictions on other activities allowed in the area such as recreation, trail maintenance, or timber harvesting.

The construction of an open-pit mine neighboring Mount St. Helens would be disastrous for the environment, put public health at risk, and would devastate outdoor recreation opportunities. With your support on Capitol Hill, we will secure a mineral withdrawal, put a stop to this mine, and permanently protect this beautiful and vitally important part of Washington. You would be supporting our vision of the future where the Green River Valley by Mount St. Helens is able to continue to inspire and be enjoyed for future generations. Together, we will ensure that the Green River Valley remains #NoPlaceForAMine!

We have a great opportunity to work together in support of the people, wildlife, and natural beauty of our region. We urge you to champion a legislative mineral withdrawal through Congress that provides permanent protections for the landscape and benefits wildlife, recreation, Indigenous communities, water, and the local economies and communities of people and businesses across southwest Washington and the entire Pacific Northwest.
