Dear Senators Rolfes, Robinson, Wilson, and Gildon and Representatives Ormsby, Bergquist, Gregerson, Macri, Stokesbary, Chambers, and Corry:

On behalf of the 64 undersigned organizations, the No Child Left Inside (NCLI) Coalition extends our sincere thanks for your part in making a historic investment in the NCLI grant program in the 2023-25 Operating Budget to better connect underserved youth to nature across Washington state. The \$2.5 million one-time investment in the program will allow State Parks and the Recreation and Conservation Office to invest \$7 million in the program in 2023-25. This level of funding will support nearly 60% of current proposals, which will allow an estimated 100 organizations to provide 77,000 youth with programming that will facilitate more than 2.6 million hours of outdoor activity.

The NCLI program provides critical support to programs that serve youth who come from low-income and historically marginalized communities across the state, in rural and urban areas alike. With this support, community-based programs can provide invaluable opportunities for youth to come together to learn, connect, and experience the healing and transformative powers of nature. Thank you for your investment in the future leaders, innovators, and advocates of our communities across the state and your commitment to connecting youth to Washington's great outdoors.

The NCLI program will change the lives of the high poverty schools that we currently serve and allow us to grow and expand that effort. We bring students to the water's edge to see spawning salmon, hear their splashes, observe behavior, but more importantly marvel at their extensive journey and celebrate their homecoming. Students learn to slow down, observe the forest through smell, touch, hearing, and even tasting some native plants which makes most of them squeal. Social emotional learning is vital to these students and we want to teach them that our outdoor spaces around our community are so special and transformative in nature. We are so grateful that this money can fun more buses, more field trips, more students and teachers to learn about the salmon life cycle, see adult salmon in the fall, release their fry from our Salmon in School Program, but also to play games, explore the natural processes around them, and even steward these places by planting trees and removing invasive weeds. When our children leave a legacy like planting trees, they can return to that park or natural space and measure their impact with the growth of that tree (50-70 years from now). If we do our jobs right, these students will not only rely on these green spaces for recharge, recreation, but hopefully they will advocate and continue to steward these places so more people can enjoy these places for many years to come.
