We believe in all American's right to public process on how public lands are managed. One of the most significant ways we are ensured this input is through the National Environmental Policy Act (NEPA).

We support NEPA for the process it provides the public for input on public lands management. We support current CEQ NEPA regulations that require agency response to public input as currently outlined in NEPA, as well as current processes that require agencies to assess likely environmental outcomes of both a proposed project and possibly better environmental outcomes. Current CEQ NEPA regulations ensure that the public is given the opportunity to participate in decisions that impact their lives and that government agencies take a hard look at the environmental and public health impacts of proposed actions as a basis for making informed decisions.
