# 6:04 PM - JANUARY MINUTES

#### 6:05 PM - TRAIL RUNNING CHAIR

- An Olympia Trail Running Committee will be created. The committee will require a minimum of 3 people and a charter that does not conflict with Mountaineers policies or Trail Running minimum standards.
- Julie Dasso was appointed the Chair by Marko. Julie will develop a charter and find a third person to be on the committee.

#### 6:11 PM - ALPINE AMBASSADORS

- Marko attended the Alpine Ambassadors program in Ouray and gave a report.
- The program was a joint training with Colorado Mountain Club. Marko said it was a good experience overall, and a great opportunity for current or emerging leaders to hone their specific skills in climbing and to keep them interested in the club after graduating from Basic or Intermediate Climbing. He made note that to date Olympia has had 6 total Alpine Ambassadors. The individuals have given back to Olympia's climbing program in big ways, volunteering to lead trips, help run courses, and assist volunteers and students. Marko noted that it would be good to continue to have Olympians apply for the Alpine Ambassadors programs.

# Kim

- \$34.000 in course revenue as of end of Jan this FY.
- Kim wants to touch base with Program Center to learn how branch reserves are separated from other funds.
- Greg Lovelady
  - o The last Board of Directors meeting was Jan 17. The topics included:
    - Building a Culture of Philanthropy
    - 2019 Gala will be April 13. Jimmy Chin will be the speaker. The Gala is a principle revenue source for Mountaineers.
    - Mountaineers Books \$250K shortfall. Maybe because no big books this past vear.
    - Total membership is up to over 13,000 members

- Banff Mountain Film Festival was very popular. Seattle profited about \$77K.
   Olympia sold out.
- The Mountaineers have about 370 Super Volunteers
- Leadership Conference was well-attended.
- Jim French is the Mountaineers Service Award Winner
- Revisions to Child Protection Policies
- (Explorers Club in Olympia already \$2000K in revenue)
- E-Learning class Protecting Public Lands 101. You get a badge for this online course
- Overall contributions and net income overall down, maybe due to Mountaineers Books.
- Risk Management is active purpose is to create a culture of continually looking at risk.
- New language was developed in the Problem Behavior policies.
- Building Fund goal to increase funds to \$11 million by 2038.
