# 1824 – MEMORIALIZE BRANCH COUNCIL'S PREVIOUS INTENT FOR BRANCH RESERVES - GREG

- Dedicating Oly Branch "Reserve Funds" To Clubhouse
- May 8, 2019 Council Meeting: Resolution adopted seeking to hold branch "reserve" funds as seed money for a possible Mountaineers' clubhouse in Thurston County.
- "Moved that the monetary assets informally known as "Olympia Branch Reserve Funds" are hereby frozen and held to be used solely for planning and other purposes closely related to the creation of a clubhouse-meeting-and activity facility for The Mountaineers organization in Thurston County; except that any of these funds previously approved by the Olympia Branch Officer's Council shall remain as formerly approved. It is further moved that this adopted motion shall be transmitted to The Mountaineers' Executive Committee for concurrence."
- It was noted that the resolution agrees with the organization's policy supporting "Teaching and Gathering Places."
- May 16, 2019 Board of Directors' Meeting
- Greg discussed next steps for the above resolution with CEO Tom Vogl.
- To gain wider organizational approval, Tom asked that we discuss this with Treasurer Don Heck and Controller Barbara Sprecher.
  - o August 7, 2019 Don Heck replies: Don had several thoughts, including:

- Our resolution has inherent merit per the organization's Strategic Plan, Vision 2022.
- There are organization-wide implications which should be considered in a broader forum. In effect, our resolution is seeking consideration so Olympia can use its reserve funds and perhaps this consideration should be extended to other branches with a similar "teaching and gathering places" objective.
- Our branch treasurer should discuss the resolution at the August 26 Finance Committee meeting.
- We should review program center proposals from the Foothills and Everett Branches as they include details that we might find helpful.
