Building a Safe and Respectful Culture


Earlier this year, the Board of Directors approved three new policies - a Member Code of Ethics, a Prohibited Behavior Policy, and a Prohibited Behavior Investigation Policy. The new policies are more clear and comprehensive so that all participants in Mountaineers activities understand behaviors that are acceptable, expectations for how we should treat one another, and how we handle complaints of inappropriate behavior.

How do these new policies affect our leaders? Our sincere hope is that the framework provided by these policies will reduce the likelihood inappropriate behavior will take place in Mountaineers activities - but also that, in the event of an incident, our leaders have the tools and process to handle complaints swiftly and objectively. This year we will be working on both a leader training module on these policies as well as member training to support the goal of physical and emotional safety in Mountaineers programs.

The Mountaineers also understands the need for a "lighter-weight" process and guidelines for more minor issues that can be resolved expediently within the committee and without staff involvement. So, what would be considered "minor" issue vs a behavior that should be handled within the more formal process? An example would include a one-time situation where the action or behavior was clearly not malicious and/or directed at an individual or a specific group of people. Another example would be an action or behavior that wouldn't be considered harassment or assault - allegations that are this serious will always be taken seriously and be investigated thoroughly and promptly.

A proposal for updating the policy with these guidelines will be discussed with the Board of Directors at its upcoming retreat on November 9-11. Shortly thereafter, we anticipate being able to share the updated policy as well as guidelines for how to handle minor issues without the need for the more formal investigation process.

Make the folder "Private" or "Shared With Committee," and the course materials are only available to students and instructors who are registered (or who have been registered in prior years) for the course!
