The heated Kitsap Cabin, has video and kitchen facilities, and space for 50 people. All field trips include use of common areas of the Kitsap Cabin property (i.e. roads, trails and restrooms), unless otherwise stated.

Your group is expected to provide: 1 chaperone per 10 youth, lunches, water & snacks, behavior management during program, supervision for bathroom breaks, and management of free time. Chaperones will also be responsible for supervising any youth who arrive without a waiver.

To confirm and reserve the Salmon Safari: We require payment in full no later than 7 days prior to the course.

Indemnification and Hold Harmless
